

The nation celebrates Older Americans Month to recognize older Americans for their contributions and provide them with information to help them stay healthy and active. This year, we are focusing on injury prevention with the theme **Safe Today. Healthy Tomorrow.** 



Older adults are at a much higher risk of unintentional injury and even death than the rest of the population. Unintentional injuries to this population result in at least 6 million medically treated injuries and more than 30,000 deaths every year. With a focus on safety during Older Americans Month, the Administration for Community Living plans to use this opportunity to raise awareness about this critical issue. By taking control of their safety, older Americans can live longer, healthier lives. Some Safety Tips to remain Safe Today. Healthy Tomorrow:

- Exercise Regularly
- Have your vision checked regularly
- Know what medications you take and how the medications interact with other prescribed medications, food, alcohol and other medical conditions you may have
- Ask if your prescribed medication may alter your balance
- Use a medication schedule box (pill box) to make sure you take what is prescribed and when prescribed

This holiday will exempt the state 4 percent state sales tax. This Sales Tax Holiday gives Louisiana residents an opportunity to prepare for storm season which will begin June 1. #### Louisiana MIPPA Grant

The Louisiana MIPPA Grant 2013 will be coming to an end for the current grant period on June 30, 2014. The participating agencies have outreached and educated Medicare eligible seniors about the Wellness and Disease Prevention services offered thru Medicare, the Low Income Subsidy Program (LIS), Medicare Part D Program and Medicare Savings Program (MSP). Thru these efforts, many seniors will be able to benefit from receiving help on their prescription medications, receive preventative care services, save money on deductibles, co-pays and premiums. Continued efforts to facilitate the MIPPA Grant activities will continue to increase the number of seniors who can be helped thru the Aging Network's efforts.

#### Louisiana **EMDAC** at work

The Emergency Management Disability and Aging Coalition (EMDAC) received special recognition for the coalition's efforts in addressing the needs of the disabled and aging during times of an emergency or disaster at the Port of New Orleans Symposium in December 2013. Thru continued efforts of the EMDAC, a tabletop discussion was held at the American Red Cross on March 18, 2014. The Purpose of the tabletop discussion was to

- Provide participants with an opportunity to evaluate current concepts, plans and capabilities for a response to an incident or emergency
- To focus on local emergency responder command and control coordination, critical decisions and notifications
- Educate participants on roles and responsibilities during an emergency
- Broaden the understanding amongst local emergency managers on planning for citizens with access and functional needs.

Participants at the tabletop discussion were representative from both the aging and disabled community with emergency managers involved in the exercise. Additional tabletop exercises are being planned regionally.
