
#### **AGING: BETTER AND BETTER**

## **TIME WELL SPENT**

LTCOP applied for and received a federal grant to help promote the LTCO program. With the help of RedSix Media, LTCOP developed a social campaign to raise awareness and increase participation in the LTCO program.

"At the heart of the Ombudsman program," says Rosa Walton, State Ombudsman, " is a collective of caring and capable staff and volunteers dedicated to preserving the dignity and rights of those in long-term care by providing an ear for those who need to be heard and a voice for those who cannot speak for themselves. It is important. It is worthwhile. It is rewarding."

Social media ads for the campaign theme, "Time Well Spent," the new poster, and other ombudsman materials bear the message, " A voice for those in long-term care."

Rosa said, "With this messaging system, LTCOP wants to convey that as ombudsmen, time spent advocating, listening, and volunteering is time well spent and position the Ombudsman program as a rewarding experience and a critical component of long-term care, worthy of one's time and effort."

This new poster will be prominently placed in Louisiana nursing homes and assisted living facilities. With the CARES Act funding, LTCOP is providing poster stands for all nursing facilities that want them. Most do. The frame allows for more visibility and functionality as it has a slot for Ombuds brochures.



## WHAT DOES THE BUILD BACK BETTER ACT MEAN TO AMERICA'S AGING POPULATION?



With midterm elections looming in November, the Build Back Better Act (BBBA) is definitely congressional legislation that older voters should keep their eyes on. The Act provides a whopping \$1.2 billion dollars for Older Americans Act (OAA) programs around the country and an additional \$4.2 billion to reauthorize and modernize the Elder Justice Act (EJA). In the context of OAA programs, \$150 billion dollars are pledged to Medicaid's Home and Community Based –Services. With some states having waitlists that can last up to 24 months, the requirement that states must eliminate the waitlist would bring instant relief. Another \$655 million dollars would go towards support for home-and community-based supportive services. Adult Protective Services

would be given \$1.5 billion dollars for grant programs. The long-term care ombudsman program stands to receive \$50 million dollars as an OAA program and another \$183 million dollars from the EJA for grants and training.

Congress has not forgotten the plight of direct care workers, so the Act provides 1 billion dollars over a ten-year period to support renewable grants for workers. \$530 million dollars would be available for legal services and medical-legal partnerships. The icing on top of this proverbial cake is surprisingly not the funding but a set of requirements that would force the nursing facility industry to establish minimum staffing requirements, require an RN on staff 24 hours per day and improve data collection. The nursing facility industry is strongly opposed to these regulations.

## **KNOW THE ANSWER?**

Q. One nursing home resident has been in the same room for eight years. One day a new roommate moves in, a roommate with hearing issues who keeps the TV blaring all day and much of the night. The new roommate refuses to accommodate the roommate and refuses to move to another room. Which roommate must relocate?

A. If no resolution is at hand, the roommate who complains may be asked to relocate – even though the resident has lived in this room for eight years. The facility should have appropriately assessed the roommates' compatibility and needs and introduced them to get to know each other before assigning them as roommates.
