## Coffee & Cases Follow-up

La. R.S. 46:153.4 (Medicaid Estate Recovery) says the Louisiana Department of Health has the authority to recover funds from a deceased Medicaid recipient's estate. However, there are hardship exceptions, including but not limited to when the estate's primary asset is a home occupied by a surviving family member who lacks alternative housing options. ## Ombudsman Certification Training: Do You Remember?

As Ombudsmen, our role as advocates is both empowering and humbling. One of the most critical aspects of our work is understanding the rights of residents and ensuring we follow proper procedures when investigating concerns. Let's review a few key points:

Permission? An Ombudsman needs only oral permission from

Permission? An Ombudsman needs only oral permission from a resident to investigate a complaint or concern, and access records of transactions or agreements. While written permission is always best, oral consent is legally sufficient. Facility Records: An Ombudsman does not have the right to request access to the facility's internal records. Our authority lies in advocating for the residents, not policing the facility.

Respect and Confidentiality: Always respect the residents' right to privacy. Information shared with you should remain confidential unless the resident gives express permission to disclose it.
