## **KUDOS TO OMBUDS**

Happy 2022

2021 was one of the most challenging years for any long-term care ombudsman program. Some state programs count hundreds among their number. Our Ombuds program may be small in numbers, but our

impact is forceful. Twenty-three ombuds (staff and volunteers) throughout Louisiana advocate for more than 35,000 residents in approximately 400 nursing homes and assisted living facilities. Louisiana ombuds helped residents transition from nursing homes to independent living, assisted them to self-advocate, and helped residents resolve issues.

## AAA + LTCOP = SUCCESS FORLOUISIANA'S OLDER PEOPLE

The Older Americans Act (OAA) requires that every state have a long-term care ombudsman program. Federal law requires AREA AGENCIES ON AGING (AAA) to consult with and support the State Long-Term Care Ombudsman Programs.

The Louisiana AAAs "sponsor, fund and coordinate local ombudsman programs; develop citizen organizations around long-term care issues; encourage long-term care ombudsman training on local levels; envision a network of volunteers and paid staff to participate in the ombudsman program throughout the state."

A MEDICARE TIP FROM BERYL
For clients with or without Medicare Part D: If your prescription drug costs are a burden, especially in the coverage gap, call your nearest AAA or Council on Aging and ask about the Louisiana SeniorRx Program. This is a statewide, free, low-cost prescription drug program that obtains drugs through drug manufacturers' patient assistance programs, and other sources. SeniorRx also provides free Medicare counseling from SHIIP (Senior Health Insurance Improvement Program, LA Dept. Ins.) trained counselors and free Medicare Part D plan comparisons.



## HELPING RESIDENTS THROUGH OLAP



Ombudsman Legal Assistance Program (OLAP) helps ombudsmen help residents. It is a free service. OLAP contracts with Southeast Louisiana Legal Services (SLLS). Shirnell Jackson is the face of OLAP.

Shirnell handles all legal requests from ombudsmen on behalf of nursing home residents statewide. She reports that in 2021, OLAP handled over 50 involuntary discharges, notarized 14 documents, and had three Medicaid appeal requests. What kept her the busiest were emergency involuntary discharges where residents had been discharged at hospitals or unsafe locations.



## **KNOW THE ANSWER?**

Q. When can an ombudsman attend a residents' council meeting?

A. When and only when invited by the residents. An ombudsman can do ONLY what the resident wants the ombudsman to do, to say. An ombudsman does not enter a resident's room without knocking and asking permission of the resident.

An ombudsman does not attend any meeting or join in any conversation unless invited by the resident.

Volunteers visit facilities more frequently, get to know the residents, and are keenly alert to residents' concerns. While volunteers help residents in particular, they are



a vital element of the long-term care ombudsman program in general, bringing fresh ideas, new skillsets, and diverse perspectives to keep the program strong and growing."
