WHO ARE "THEY"?

"They" are state-supported, federally mandated "ombuds" created by the 1978 Amendment to the Older American's Act. Their mandate is to investigate, advocate and resolve long-term nursing home and assisted living facility residents' complaints and concerns. Their fundamental governing principle? When a person moves from home to a nursing home, their rights move with them.

THEY are advocates for RESIDENTS' RIGHTS

October is Residents' Right Month commemorated annually by Consumer Voice to honor residents in long-term care facilities and all older persons who receive services in their home or community. This year's theme, "Reclaiming My Rights, My Home, My Life" recognizes the pandemic's impact, and in Louisiana, the impact Hurricane Ida had on residents. The theme also focuses on raising awareness of federally mandated residents' rights while underscoring the need for dignity and self-determination of all residents.

Ombuds across the nation are holding "Right To Have Fun"
Drives, organizing "letter to the editor" programs discussing
Residents Rights or advocacy groups raising their voices
about stafing shortages in long-term care facilities. In
Louisiana, ombuds commemorate their residents' rights in
many ways but in each way they let the residents know that
"they always have someone to call on: their ombud."
Louisiana residents rock!

DID YOU KNOW?

Ombuds were created by the 1978 Amendment to the Older Americans Act.

Where do Ombuds get their authority? The 1987 Nursing Home Reform Act, OBRA'87, gives Ombuds 24/7 access to residents.
